How ŠKODA 3 Year Fixed Price Car Insurance works

The premium shown in the enclosed Schedule for your first year of cover will not change for the next two years subject to the Terms and Conditions below. Please read these together with the full Policy Terms booklet enclosed:

- › The premium will be fixed for two consecutive renewals, providing you choose to renew cover annually.
- › The fixed price offer will no longer apply if you or a named driver gain a motoring conviction or make a claim (excluding windscreen claims) after your policy has started.
- › The premium at your next renewal will change if you make an amendment to your policy, such as changing your car or address. The revised premium will be fixed for the remaining renewal periods.
- › The fixed price offer does not apply to optional additional products and Insurance Premium Tax price changes.

Please note: If you pay by instalments, payments for your first year of cover will be made up of a deposit followed by 10 monthly instalments. If you choose to renew your cover, the annual premium amount you will pay in year two and three will remain fixed, however, your payments will change to 12 equal monthly payments so may look different.
